

MINUTES OF HIGH HAM PARISH COUNCIL MEETING HELD AT HIGH HAM VILLAGE HALL ON TUESDAY 26th February 2019

Present: Dave Vigar (Chairman), Nancy Green, John Vigar, Jim Godfrey, Bryan Bartlett, V Young (Clerk).

Approx: 13 parishioners

Meeting opened at 7.30pm.

- **1)** <u>Apologies</u>, Amanda Chuter, Chris Palmer, Gerard Tucker (District Councillor) Clare Aparicio Paul (County councillor).
- 2) <u>Declarations of Interest on agenda items:</u> Nancy Green declared an interest in item 6c being the applicant.

3) Open Discussion:

Clive Miller spoke about the infilling policy which was a new national policy which would be taken into consideration on applications. Hamlets can be infilled if near other large settlements/villages. The example that they were considering in this case was whether to apply for permission on a paddock next to Tibbs House. The policy did recognise the importance of the countryside and was only for limited infill on a small scale allowing self builds. If people wished to self build they would need to register with South Somerset District Council. There was a possibility of using a plot for infill to meet the aspiration of a local family to stay in the hamlet of Henley

Work re the tree on the green – discussed.

Thefts of bicycles in the area mentioned and also a few shed thefts – please lock up sheds.

4) Councillors reports

Written reports had been sent in and circulated to council members for both the County and District Councillor reports. The District Councillor report highlighted that the application for the heights which was retrospective had been refused. The request regarding a pavement by the school on a planning application had also been considered and would need funding from another source which would be difficult to secure due to the large amount of investment required.

5) <u>Approval of Minutes</u> - The minutes of the meeting held on 22nd January 2019 were approved as a true record with one minor amendment. The issue of Wi-fi at the Village Hall was briefly discussed. It was known that grant funding for it would be available. John Vigar to take the matter forward with the Village Hall committee.

6) Planning Applications for Consideration

a) 19/00119/OUT Address Land Between Teddy Bear Cottage And Lyncot Hamdown Court, Picts Hill Langport Somerset

Proposal Outline application for the erection of 1 No. new dwelling. with some matters reserved except access, layout and scale. After discussion it was unanimously resolved to offer no objections.

- b) 19/00139/HOU Address South View Picts Hill Langport Somerset TA10 9EX Proposal Erection of a two storey rear extension. After discussion it was unanimously resolved to offer no objections.
- c) 18/03919/COL Address Yew Tree Farm Henley Road High Ham Langport TA10 9BH Proposal Application for a Lawful Development Certificate for proposed single storey side extension. Nancy Green did not take part in any discussion on this item. The discussion was limited to the fact that the Parish Council had not been consulted on the application as it was not a full planning application, but if anyone wanted to make comment on the application they could do so directly to the planning department.

It was noted that the application for revised tree works at Hamdown had been received by the District Council.

18/02285/FUL The Heights Main Road High Ham - The carrying out of alterations and engineering works to level rear gardens, and formation of a roof terrace. (Part Retrospective) - Refused

- **8b) Highways** progressing regarding the reported defects large pot hole outside Field House to be reported. In places highways to be asked if they can reinstate the verge where they are insistent that the unevenness is not a pothole on the carriageway. Lots of ditching work being done in the Parish which has brought up a lot of items that were fly tipped in the rhynes. Bryan to ask Street Scene if it could be removed as fly tipping.

£50 received for wood sales. Craig would be asked to look at the drains in Long Street where it was thought tree roots were growing down into the drain.

14.02.19 Little Green. Bollards installed to prevent further erosion of the green by passing and parking vehicles

Email correspondence had been passed on to the High Ham Parish Group where appropriate. Chris Palmer had heard back with reference to the fire hydrants and the fire brigade would look and help Parish Council with the exercise to identify the hydrants in the Parish.
